

# Regulation

August 2025

#### **Article 1 // Categories**

There is one overall category for men and women for the long and the short loop. The long course includes about 92 kilometres and 1700 metres of altitude. The shorter route covers a lap of around 60 kilometres and 1100 metres in altitude.

## **Article 2 // Participant Fee**

The participant fees vary from destination, race format and time of the registration. Head to the sub-site of each destination on the website <a href="https://www.chasingcancellara.com">www.chasingcancellara.com</a> for further details.

## **Article 3 // Late Registrations**

Late registration is possible up to 60 minutes before the start of the race. A late registration fee of CHF 10.00 will be charged compared to the online registration.

#### **Article 4 // Formats**

All participants start in medium-sized groups. Groups are allocated based on the average speed indicated. Time is only measured on the five defined climbs: Schellenberg, Triesenberg, Sankt Luzisteig, Sankt Luzisteig and Triesenberg. On the shorter loop, the time will be measured on the Sankt Luzisteig, Sankt Luzisteig and Triesenberg climbs. Between the climbs the race will be neutralized. The total of the times from the climbs gives the ranking.

#### **Artikel 5 // Teamwertung**

Each team member completes the 92 kilometers of the big loop as a single. At the end, the times of the three fastest team members are cumulated and give the result of the team ranking. At least three people must be registered with the same team name. In order to be counted as a team, the identical team name must be given at the registration. Already registered participants can change or add their team name by sending a message to info@chasingcancellara.com.

## **Article 6 // Equipment Bicycle**

Aero handlebars are forbidden. Any motorized support at the bicycle or E-Bikes are strictly forbidden. If there is found a fraud, the participant will instantly be stopped and disqualified.

#### **Article 7 // Award Ceremony & Finisher Party**

After the race, the ceremony for the winners is held. At the same time, the finisher meal for all participants takes place.

#### **Article 8 // Refund Participant Fee**

The registration is to be made on the internet. Registrations over phone or via mail are not accepted.

The organizer has the right to disqualify participants without refunding if they registered with wrong personal information, if they violate any rules or if there are reasonable suspicions with regards to the using banned substances.

Duplicating online registrations made by mistake will not be refunded but will entitle you to a free start at a Chasing Cancellara event in the following year.

If a participant is unable to take part due to injury or illness, the starting place will only be refunded with valid cancellation insurance and a corresponding medical certificate. Cancellation insurance can be taken out at the time of registration.

If an existing starting place has to be transferred to another participant, Sette Sports will charge an administration fee of CHF 20.00.

If the race cannot be carried out or only partially carried out due to force majeure, extraordinary risks or official order, there is no entitlement to a refund of the entry fee.

### Article 9 // Daily schedule at race day

The times vary from place to place and will be published on the website <u>www.chasingcancellara.com</u> on each event site prior to the events.

## **Article 10 // Registration and Time Keeping**

The registration and time keeping will be conducted by Race Result and all information can be found on the platform of Race Result. The organizer of Chasing Cancellara has the right to use photos, videos and voice recordings of the riders for promotion purposes in the future.

### **Article 12 // Terms and Conditions**

With the registration, I acknowledge the announcement and the disclaimer for the organizer of damages of every type. I will neither against the organizer nor against the sponsors of the event and their representatives make claims for damages and injuries of every type which can occur during my participation. Each participant has to sign the waiver when picking up the BIB number. I confirm that I have sufficiently trained for the participation at this run and that I am physically healthy. The insurance is the issue of the participants. The medical personal is justified to take me out of the race if there are any signs of a damage to health. I agree that the in the registration named data can be used for the purpose of the event. I assure the correctness of the made information. Your data will be stored electronically!

#### Article 13 // Data collection and Data utilization

The personal data which are stated during the registration will be stored and used for the payment and registration process. The athlete agrees with the registration to store the data for this usage. The data protection regulation can be found on the Chasing Cancellara Website / Race Result platform.

#### **Article 14 // Regulation changes**

The organizer has the right to change the regulation, the course and the schedule at any time. Changes will be published on the website and/or directly communicated to the registrants.
